INTELLECTUAL PROPERTY ORGANISATION (WIPO)

A delegation from the World Intellectual Property Organization (WIPO) led by the Country's

Director, Mr. Oluwatobi Olakunle was at the Nigerian Law School Headquarters, Bwari-Abuja on a courtesy visit to the Director-General on October 6, 2022. The team was received and welcomed by the Director-General, Prof. Isa Hayatu Chiroma, SAN at his Conference Room.



The Director-General was accompanied by the Secretary to the Council and Director of Administration, Mrs. Elizabeth Max-Uba, Director and Head of Academics, Mr. Samuel Osamolu, Directors and Heads of Academics from the campuses and Director of Administration, (Information and Protocol) were also present.

WIPO needs an opportunity to create awareness and address the Students, he concluded.

be happy to work with them particularly in the area of training and knowledge development for both Staff and Students.



According to the Director-General, there is also an important need for Staff and Students to know more about WIPO. Consequently, a platform will be created for WIPO to come and address the Students when they resume. He concluded that the Council of Legal Education and Management of the Nigerian Law School will look further into creating a more formal relationship between WIPO and Nigerian Law School that will be beneficial for both bodies.
