THE BAR PART II RESULTS FOR 2021/2022 CANDIDATES RELEASED

The Council of Legal Education, Nigerian Law School has released the result of 2022 Bar Final Examinations, conducted in the month of August/September 2022. The results were released on November 16, 2022 after Council's approval at the Council meeting held on November 16, 2022. The executive summary of the result showed that out of 5,802 students who participated in the exams, 4,689 were recorded as successful, 185 conditional pass while 922 candidates failed and 6 withheld.
